Explanation: For the purpose of this clause, the term "business registration license" means a certificate obtained by a construction entrepreneur pursuant to the law in force relating to construction enterprises with the objective of carrying out a construction business.
  - Value Added Tax registration certificate and Permanent Account Number (PAN) registration certificate,
  - Tax clearance certificate FY2076/2077 or the document of having submitted tax returns of the period specified by the Public Entity obtained from the Inland Revenue Office,
  - A written declaration made by the bidder with a statement that he/she is not ineligible to participate in the procurement proceedings; has no conflict of interest in the proposed 32 procurement proceedings, and has not been punished for a profession or business related offense.
  - For the bidder's within the municipality should be registered in the Municipality.

5. Sealed must be submitted to the office **”Jeetpursimara Submetropolitan City Office of the Municipal Executive jeetpur, Bara”** by hand/courier on or before the deadline. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at the **”Jeetpursimara Submetropolitan City Office of the Municipal Executive jeetpur, Bara**. Bids must be valid for validity period after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in following account and submit the receipt of the deposited amount of cash along with the bid
7. If the last date of purchasing, submission and or Opening falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
